President Hall welcomed everyone and thanked them for attending.

The **minutes from the previous meeting in December** were presented by Mike Brammer. <u>A motion made by Kessler/Moser to accept the minutes as presented</u>. The motion passed. <u>Motion to concur by Wickard/Hines</u>. Motion passed.

Financial reports were presented by Mike Brammer. Written reports were provided for the current year budget comparison, a listing of checks and deposits since the last board meeting, and a listing of CD's. With no objections the reports will be filed for audit.

The State Officer Activity Report was presented by Sarabeth Royer. A written report was provided.

FFA Foundation report was presented orally and written by Stephanie Shirk.

ACES 2012 review given by Matthew Dodson.

SLLC Preview was presented by Tyler Claypool and Sarah Kessler. 414 registered. This is the 25th anniversary of this conference.

Ag Career Network/membership update – Mike Brammer reported changes continue on the AgCN. A discussion on extending the deadline for rosters without a penalty fee followed. Motion – Hall/Steinfelt moved to extend the deadline to May 1, 2012 without penalty. Motion passed. Schaeffer/Kessler moved to concur. Motion passed.

OLD BUSINESS

Policy Manual revisions – *Motion by Schaeffer/Claypool to accept the policy manual as presented. Motion passed. Hines/Steinfelt moved to concur* – *Motion passed.* Recommended that everyone review before the second vote in May!

NEW BUSINESS

Mileage reimbursement proposal — A proposal was presented to increase the mileage rate used by PA FFA. Foster/Hall moved to match the state rate for mileage reimbursement. Foster/Hines moved to postpone definitely until the May Board meeting so this matter could be included in the policy manual. Motion passed. Dodson/Kessler moved to concur. Motion passed.

Foster to provide a written recommendation to the policy manual committee.

Benefit Walk proposal presented by Jenna Moser. *Hall/Schaeffer moved to allow the name PA FFA be used with this event and Jenna Moser to serve as the coordinator.*

Foster/Hines moved to refer this matter to a committee of four, consisting of a representative of the Foundation, Alumni, and two State Officers, to be appointed by the chair and report back in June. Motion passed. Dodson/Royer moved to concur – Motion passed.

ANNOUNCEMENTS

Vet Tech CDE - Teams that participate in the 2012 pilot National vet science CDE can participate in the 2013 official event, if they meet all the other eligibility requirements including current membership and grade in school. Teams that compete in the 2012 pilot event cannot participate in another CDE that same year. *Motion by Hall/Wickard to allow the top two teams (in order) placing at the state event to attend the National CDE (at their own expense). Motion passed. Schaeffer/ Kessler moved to concur. Motion passed.*

Mike Brammer announced at the next Board meeting in May we will need to elect a President and Vice President for the 2012-13 year.

Mike Brammer announced at the next Board meeting we will need to confirm the Eastern Region Board member who will serve on the nominating committee for FFA in June. Gretchen Dingman has been informed and is considering the appointment. Past State Officer will be from the Northern Region while we will need two business & industry reps from the South Central and Western Regions.

Ron Frederick asked about the following:

Should there be a code of conduct form used for ACES and SLLC? Suggested we include this in the policy manual.

Should students from chapters be roomed together at conferences? Concluded that we can split them up if chapters are willing to pay additional costs.

Dr. Foster asked for copies of the Policy Manual and Constitution and By-Laws to be available at each Board meeting.

Nailor suggested a list of courtesy corps policies be formed to be included in the policy manual.

The meeting was adjourned with closing ceremonies at 8:55pm.


Report for PA FFA Association Board Meeting March 9, 2012

Farm Show

Overall, the 2012 Farm Show was a success for the FFA Foundation. With help from PDA, the Foundation sponsored an awards reception for national trip winners to be recognized with Secretary of Agriculture, George Grieg. There were many legislators also in attendance.

The Farm Show Food Stands also received positive outcomes. The Foundation extremely appreciates the partnership with Snyder's Concessions and Bob Corman to operate the pizza stand smoothly. The pizza stand was very popular and brought in a gross income of \$48,507.80 with a Foundation net income of \$17,855.77. The traditional Hatfield stand in the Main Hall Food Annex grossed \$61,112.72 and a Foundation net income of \$17332.50.

If anyone has suggestions on how to entice FFA chapters and members to work in the food stands, please let us know. We are grateful for the 245 student volunteers. The Foundation paid \$5563.50 student workers this year. Below is a graph that illustrates the student help versus the outside help necessary. This does NOT include the help Snyder's Concessions provided for the pizza stand. This is additional help arranged by Stephanie Shirk to fill the holes where FFA members and volunteers left spots empty.

The Foundation has revamped its website to a more user-friendly editing system to allow changes via any computer with an internet connection. The software is similar to a MS word application, therefore allowing more frequent changes. The Foundation is also setting up a PayPal account to accept donations. This will allow transactions to occur without the bookkeeper or administrative director having access and responsibility of customer financial information. Academics and Vocational Education:

New Keystone Testing proposals have three core subject tests to be given at the conclusion of students Biology, Algebra I and English Language Arts classes that students must be proficient in to graduate. PSSA testing will be phased out as these Keystone tests are required for the 2012 incoming freshmen class. Public hearings over the next two months will finalize PDE testing requirements.
