# Approved FFA Board Minutes – August 26, 2011

### POLICY CHANGE - SECOND VOTE - NOW POLICY

Claypool/Moser moved to change Policy on CDE Restrictions page 10 to state: FFA members are restricted from competing in more than one public speaking contest on the state level. Public speaking contestants are the ONLY members permitted to compete in two conflicting (same day) contests. Other FFA members may compete in more than one CDE, providing they are not conflicting. If any other member participates in two conflicting (same day) contests at FFA Activities Week they will be disqualified from both.

**NEW Keystone degree application and verification process was discussed** lead by Dingman, Day and Nailor. Mr. Day reported verifications will take place on November 19 at PDA starting at 9:30am.
