 Attire Official Dress If weather allows, portions of the soil component may be outside. 	CDE At-A-Glance (List of major components) When teams arrive for their designated team time slot on Wednesday, they will complete: Individually - A Soil Evaluation Test (30 minutes) Team Scenario Prep (1 hour) Team Scenario Presentation (~13 minutes: 8 minutes to present and 5 minutes for judges' questions) Note: This CDE will be happening at the same time that the team members will be competing in the Wildlife and Aquatic CDE's in the same building. Team members will be pulled at their scheduled Team Time. The schedule will allow them to complete all portions of all 3 CDE's.

Pre-State CDE Expectations

 Determine which students make-up the 4-person team, and of the team, which 2 students will be competing in the Aquatics CDE and and which 2 students will be competing in the Wildlife CDE. When registering for States, make sure that is very clear in the State Registration.

CDE Changes from Previous Years?

- REMINDER: ENR Teams must have 2 students compete in the Wildlife CDE and 2 compete in Aquatics CDE!
- (NEW for 2024) ENR Teams will be competing on Wednesday simultaneously while team
 members are competing in Wildlife or Aquatic CDE. Team members will be pulled from their
 respected CDE on Wednesday for their ENR Team Event.
 - All teams will be informed of their Team Event Time Slot by email a week prior and also on Tuesday at either the Wildlife CDE or Aquatic CDE.

Individual scores from Soils (Wednesday)	400 pts	(100 pts possible per student)
Team Event (Wednesday)	900 pts	All four members must participate in the preparation and presentation of the plan and answer panel questions. This will also include a score from the written proposal.

Additional Information:

Team Event Scenario:

- All team members must be present in official dress to begin the team event.
- Team members will have access to a computer (no internet) for 1 hour to type a proposal based on the Scenario Topic. Judges will review the team proposal prior to presentation and will evaluate both the presentation and the typed proposal.
- During the 1 hour prep time, members will also have access to materials needed to make a visual display to supplement their proposal and presentation.
- Team members will then present the proposal to a group of judges for a maximum of 8 minutes with additional 5 minutes for judges' questions.
